

EXA CORPORATION SOFTWARE PRODUCT LIMITED TERM LICENSE AGREEMENT

Important information, please read this first.

The enclosed Software License Agreement ("Agreement") is a legal Agreement between you as an individual or as an organizational entity (the "Licensee") and Exa Corporation ("Exa"). Using the Software indicates your acceptance of these terms.

1. GRANT OF LICENSE. Exa grants the Licensee a nontransferable, nonexclusive, limited term license to use and possess the Software, related Documentation, and Best Practices and Methodologies to be used only in conjunction with the Software, for its intended purposes. Software possession and use will be in machine-readable form, on the Licensee System at the Designated Site identified on the Purchase Order, placed under this Agreement, for the term set forth on the Purchase Order. One machine-readable copy of the Software may be made for back up purposes only and shall display all proprietary notices included in the original copy. Documentation and Best Practices and Methodologies possession and use may be in written or digital form.

2. COPYRIGHT. The Software and related written or digital materials are the property of Exa and its licensors, is protected by patents, trademarks and international copyrights, and is provided to Licensee only on the license terms set forth in this Agreement. Licensee may not copy any written materials accompanying this Software. All copies in the possession of the Licensee are and shall remain exclusively the property of Exa.

3. OTHER TERMS AND RESTRICTIONS. Licensee may not transfer its rights under this Agreement without Exa's prior written consent. If Exa consents to a transfer, the party to whom such rights are transferred must agree in writing to be bound by the terms and conditions of this License. Upon such transfer, Licensee must transfer or destroy all copies of the Software. Licensee may use a third party vendor to host Exa software solutions on behalf of Licensee. The third party host will be bound by the same license terms and conditions as Licensee, and Licensee agrees it is responsible for third party compliance with Exa license terms and conditions. Licensee may not modify, reverse engineer, decompile, disassemble, distribute, sub-license, sell, rent, lease, give or in any way transfer, by any means or in any medium, the

Software, related Documentation, and Best Practices and Methodologies to be used only in conjunction with the Software, and will use its best efforts and take all reasonable steps to prevent unauthorized use, copying or dissemination. Licensee will maintain all proprietary notices intact.

4.LIMITED WARRANTY. Exa warrants the Software media to be free of defects in workmanship for a period of ninety days from purchase. During this period, Exa will replace at no cost any such media returned to Exa, postage prepaid. This service is Exa's sole liability under this warranty. THE WARRANTIES GIVEN IN THIS AGREEMENT ARE THE ONLY WARRANTIES GIVEN BY EXA WITH RESPECT TO THE SOFTWARE AND SERVICES AND ARE GIVEN IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY AND OF FITNESS FOR A PARTICULAR PURPOSE. LICENSEE'S EXCLUSIVE REMEDIES, AND EXA'S SOLE LIABILITY, FOR ANY NONCONFORMITY OR DEFECT IN THE SOFTWARE SHALL BE THOSE EXPRESSED HEREIN.

5.INDEMNIFICATION. Exa will defend or, at its option, settle any claim, action, or proceeding (collectively "claim") brought against Licensee that the Software directly infringes a United States patent, copyright or other proprietary right of any person, and shall indemnify Licensee against all damages and costs finally awarded against Licensee in any such action or proceeding which results from any such claim. Exa shall have no liability hereunder unless Licensee promptly notifies Exa in writing of the claim, gives Exa full authority, information and assistance to defend such claim, and gives Exa sole control of the defense of the claim and all negotiations for the compromise or settle thereof. In the event the use of the Software is enjoined, Exa shall have the right, at its option and expense, either to procure the right for continued use, non- infringing, or refund the Licensee fees paid under this Agreement less a reasonable allowance for Licensee's use of the Software.

6.PAYMENTS AND TAXES. Licensee agrees to pay the Software and Maintenance fees as invoiced by Exa in conjunction with the binding arrangement including but not limited to the Purchase Order, order agreement, or contract, accepted by Exa under this Agreement. The Software and Maintenance fees and all other charges under the Agreement are exclusive of all sales, use, excise, VAT and other taxes and delivery charges. Exa shall be paid by the Licensee for any taxes and other charges.

7.MAINTENANCE. Subject to Licensee's timely payment of renewal fees,

Exa will make available to Licensee, for use in accordance with this Agreement, any enhancements which Exa incorporates into the Software. All enhancements, in any form, will be considered "Software" for the purposes of this Agreement and will remain the property of Exa.

8. TERM AND TERMINATION. This Agreement is effective from the date of Software installation on the Licensee System at the Designated Site identified on the Purchase Order for the term set forth on the Purchase Order. Software keys must be supplied by Exa to enable usage of the Software. Either party shall have the right to terminate this Agreement in the event that any material breach by a party remains uncured for a period of thirty days following the breaching party's receipt of written notice from the other party.

9. LIMITATION OF LIABILITY. UNDER NO CIRCUMSTANCES SHALL EXA'S LIABILITY ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR EXA'S PERFORMANCE OR ASSERTED FAILURE TO PERFORM HEREUNDER, IN CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, EXCEED THE MONIES ACTUALLY RECEIVED BY EXA UNDER THIS AGREEMENT DURING THE TWELVE MONTH PERIOD PRIOR TO THE CLAIM OF LIABILITY BEING MADE FOR THE SOFTWARE AND SERVICES PROVIDED HEREUNDER TO WHICH SUCH LIABILITY RELATES. IN NO EVENT SHALL EXA BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, OR DAMAGES RESULTING FROM LOSS OF USE, PROFITS, BUSINESS OR GOODWILL, WHETHER OR NOT EXA HAS BEEN ADVISED OF THE POSSIBILITY THEREOF. LICENSEE'S SOLE RELATIONSHIP UNDER THIS AGREEMENT IS WITH EXA. UNDER NO CIRCUMSTANCES SHALL ANY OF EXA'S LICENSORS HAVE ANY LIABILITY WHATSOEVER TO LICENSEE.

10. U.S. GOVERNMENT RESTRICTED RIGHTS; EXPORT RESTRICTIONS. If Licensee is an agency or contractor of the United States Government, Licensee acknowledges and agrees that (a) the Software and Services were developed entirely at private expense, (b) the Software and Services in all respects constitute proprietary data belonging solely to Exa, (c) the Software and Services are not in the public domain, and (d) the Software is "Commercial Computer Software" as defined in sub-paragraph (a)(1) of DFAR Section 252.227-7014 or FAR Part 12.212. Licensee agrees not to store or process any data (a) in violation of any U.S. export control law or regulation or (b) that is subject to the International Traffic in Arms Regulations maintained by the United States Department of State.

11. GENERAL PROVISIONS. This Agreement embodies the entire understanding between the parties with respect to the terms and conditions set forth herein, and those terms and conditions shall control over any terms and conditions set forth in any associated Purchase Order or prior

agreement, quotation, proposal, correspondence or oral discussion relating to the subject matter hereof. This Agreement shall not be amended or modified except in writing fully executed and delivered by the parties hereto. This License shall be controlled by the laws of the Commonwealth of Massachusetts and the United States of America.
